### Mine Subsidence

It's been said that April showers bring May flowers, but for some Illinois property owners, you may have other concerns these next few months besides a little rain. At one time or another, 72 Illinois counties have been a part of the 4500 mines underlying more than 750,000 acres, and this time of year, as the ground thaws and softens from melted snow and spring rain showers, some of those old mines can collapse.

Standard property policies exclude earth movement as a covered cause of loss, meaning earthquake, landslide, earth sinking & shifting and mine subsidence would not be covered. But there are endorsements available for you to "buy back" some of that coverage. Mining was extensive enough in 34 counties in Illinois that a mine subsidence endorsement is automatically included in your property insurance.

You can choose to waive it of course, but it's fairly inexpensive protection. The cost to add coverage for one year usually ranges between \$49 for \$100,000 in coverage up to \$126 for \$350,000 in coverage.

The Illinois State Geological Survey (ISGS) has information about mining activity in Illinois, but that should be used as a guide, not a definitive yes-or-no resource. It's hard to say you do or you don't need this insurance, because you'll never really know you should've had it until the moment a loss occurs.
